

INFORMATION CLAUSE FOR CONGRESS PARTICIPANTS

"IV ASC - AVIATION AND SPACE CONGRESS"

Pursuant to Articles 13 and 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (OJ EU L 119 of 04.05.2016), hereinafter the "GDPR", we hereby inform you that:

1. The Data Controller is Rzeszów University of Technology (Politechnika Rzeszowska im. Ignacego Łukasiewicza), al. Powstańców Warszawy 12, 35-959 Rzeszów, Poland;

2. Data Protection Officer: You may contact the Data Protection Officer of Rzeszów University of Technology by e-mail: iod@prz.edu.pl or by phone: 17 865 1775.

3. Purposes and legal bases of processing: Your personal data will be processed for the following purposes:

a) Registration and organisation of the Congress: to handle your application, communicate with participants, prepare badges and materials and provide catering – on the basis of Article 6(1)(e) GDPR (performance of a task carried out in the public interest, namely dissemination of science);

b) Financial settlements and archiving: to comply with legal obligations (tax, accounting, archiving) – on the basis of Article 6(1)(c) GDPR;

c) Publication of your image (as part of a larger whole) – on the basis of Article 6(1)(f) GDPR, i.e. the controller's legitimate interest, understood as publishing a photo report from the Event in connection with promoting the University's activities in the public space and building a positive image among the public;

c) Publication of your image (portrait photographs, cropped) – on the basis of Article 6(1)(a) GDPR (consent of the data subject), to the extent that the person has given separate, voluntary, informed and unambiguous consent to the dissemination of their image. Failure to give consent does not entail any negative consequences for the person;

d) Assertion of claims: possible establishment, pursuit or defence against claims – on the basis of Article 6(1)(f) GDPR.

4. Social media and joint controllership with platform providers: In connection with promoting the Congress on social media platforms, the providers of those services are also

joint controllers of your data with regard to statistics and the operation of the profile. Details of processing are included in the providers' privacy policies:

5. DISCLOSURE OF DATA

Your personal data in the form of a recorded image will be disclosed to the event co-organisers, i.e.:

Recipients of data: The recipients of your data may include:

- entities authorised to obtain data under applicable law;
- entities providing services to the Controller (e.g. IT support, payment systems, hotel services – if applicable);
- recipients of content on the Internet (in the event of publishing the image in a report from the event).

6. Transfer of data to third countries: As a rule, data are not transferred outside the European Economic Area (EEA). However, due to the publication of reports in social media (Facebook, YouTube, LinkedIn, X, TikTok), data may be transferred to servers in third countries (in particular the United States). Such transfer is carried out on the basis of a European Commission adequacy decision (Data Privacy Framework) or Standard Contractual Clauses.

7. Data retention period: Data will be stored for the period necessary to organise and settle the Congress, and then for the period required by archiving law (in accordance with the Uniform File Classification and Retention Schedule of Rzeszów University of Technology). Data processed on the basis of consent (posed portrait image) will be processed until the consent is withdrawn.

8. Rights of data subjects: You have the right to:

- access your data and receive a copy;
- rectification (correction) of data;
- erasure of data (in cases provided for in the GDPR);
- restriction of processing;
- data portability;
- object to the processing of data;
- withdraw consent at any time (without affecting the lawfulness of processing carried out before withdrawal);
- lodge a complaint with the President of the Personal Data Protection Office (ul. Stawki 2, 00-193 Warsaw, Poland) if you consider that processing infringes the GDPR.

9. Information on voluntary provision of data

Provision of data is voluntary but necessary to participate in the Congress. Refusal to provide data will result in the inability to register and participate in the event.
